

- Ireland is the 9th biggest investor in the United States
- Over 500 Irish companies have operations across all 50 US states, employing almost 100,000 people
- · US companies employ 210,000 people in Ireland and a further 168,000 indirectly
- · Spend of US multinationals in the Irish economy in 2022:
 - €16bn on payroll
 - €14.2bn on capital expenditure
 - €10.8bn on goods and services
- · 1 out of every 3 US multinationals in Ireland have been here for more than 20 years
- · Ireland is home to 9 of the top 10 US technology companies, 9 of the top 10 pharma companies, and 14 of the top 15 MedTech companies (IDA)
- · Over 30 million US citizens claim Irish heritage
- Irish exports to the US increased by 14% from 2021 to 2022
